



GROUND TRANSPORTATION

Door-to-Door Van Services Nearly a dozen door-to-door van services operate from all terminals at SFO. Average fare is USD 15-20 per person.

Taxi Taxi service is available from SFO to downtown. Approximate fare to a downtown destination is USD 40 to 50. Voluntary ridesharing for two more persons with a maximum of three destinations is permitted.

Car Rentals Auto rental counters are located in the centralized SFO Airport Car Rental Center. To access the Rental Car Center from the airport terminals, take the AirTrain Blue Line.

Bay Area Rapid Transit (BART) The 103-mile BART system links eight San Francisco stations with San Francisco International Airport to the south and 20 stations in the East Bay. Trains operate seven days per week, from 4 a.m. to midnight on weekdays, 6 a.m. to midnight on Saturdays, and 8 a.m. to midnight on Sundays. Reference www.bart.gov/ for accurate schedules and service alerts.

Muni Metro or Light Rail Vehicles Six lines are available: J (Church), K (Ingleside), L (Tarval), M (Ocean), N (Judah), T (Third Street). Historic streetcars (F-line) operate along Market Street, beginning in the Castro District and terminating at Fisherman's Wharf.
